Volunteer Agreement and Release of Liability Form

I, _____, state that I have applied to be a volunteer with L.I.F.E. House for Animals, Inc., and that I hereby acknowledge and agree to the following; and/or I, _____ (if applicable), hereby certify that I am the parent/guardian of the above named volunteer and agree to the following:

1. That I will follow and abide by the procedures, policies, and training presented to me for participation as a volunteer, and will take any comments, complaints, or suggestions regarding L.I.F.E. House for Animals, Inc. to the Board of Directors. Failure to abide by the procedures, policies, and training may result in immediate dismissal as a volunteer.
2. That I authorize L.I.F.E. House for Animals, Inc., to seek emergency medical treatment for me in case of accident, injury, or illness. Furthermore, I understand that it is important to have a tetanus vaccination before becoming a volunteer, and thus I understand that it is important to discuss being vaccinated against tetanus with my physician. I therefore release L.I.F.E. House for Animals, Inc., from all injuries, claims, or other loss that I may incur because of my not pursuing this matter further and receiving a tetanus vaccination.
3. That neither this agreement nor my participation as a volunteer shall be interpreted or give rise to an employee/employer relationship between myself and L.I.F.E. House for Animals, Inc. I understand that while participating as a volunteer I will receive no compensation or other employee benefits.
4. That I understand that the behavior of domestic animals is at times unpredictable and that some domestic animals are capable of inflicting property damage, serious personal injury, and even death. I am well aware of the risks of handling domestic animals, and with such understanding, I hereby waive, release and forever discharge L.I.F.E. House for Animals, Inc., its volunteers, Board of Directors, or agents from any and all claims (whether present or future) arising out of my participation as a volunteer.
5. That further, I promise to be present for scheduled shifts and carry out duties promptly and reliably or, if I am unable to carry out my duties, I will immediately contact the appropriate person. I will maintain the dignity and integrity of L.I.F.E. House for Animals, Inc. with the public and will honor confidential information. I will accept evaluation of my performance as a volunteer. I will notify L.I.F.E. House for Animals, Inc. of any extended leave or resignation.
6. That I have read and understand this entire Agreement, specifically the release of liability in paragraphs 2 and 4, and acknowledge that participation as a volunteer will be at my sole risk. I further agree that if any portion of this agreement is held invalid, the remainder thereof will continue in full legal force and effect.

CODE OF CONDUCT L.I.F.E. House for Animals, Inc.

Dress:

- ☛ No low cut shirts, crop tops, or excessively short shorts.
- ☛ Sturdy shoes covering the entire foot. No sandals or clogs.

Personal Boundaries:

- ☛ No inappropriate touching, consensual or otherwise.

Behavior:

- ☛ No cigarettes, drugs, or alcohol allowed on the property.
- ☛ Maintain a respectful voice level for the animals and humans.
- ☛ No disrespectful or profane language.
- ☛ Do not bring electronic equipment to the shelter. Cell phones are allowed but must be turned off.
- ☛ All food and drinks are not to leave the kitchen area.
- ☛ Treat ALL shelter guests with respect and compassion.
- ☛ Treat ALL shelter volunteers and the public with respect.
